- A 2-0-0 NITROGENOUS FLUID FERTILISER WITH IRON. To be used only where there is a need. Do not exceed recommended application rate.
- Total Nitrogen (N) 2.0% Total Iron (Fe) 6.0%

## SAFETY PRECAUTIONS

### Operator Protection

## DIRECTIONS FOR USE

**IMPORTANT: This information is authorised as part of the Product Label. All instructions within the 'directions for use' sections must be read carefully in order to obtain safe and successful use of this product.**

Shake before use. Apply 1.5 litres in minimum of 5 litres of water per 100 sq. metres (for details see application rate table opposite). Apply to actively growing turf in moist conditions from early spring to autumn. The grass should be cut three days before treatment and not cut again until at least four days after treatment. Do not apply if rain is imminent but water in if no rain has fallen within 48 hours. Avoid walking in treated areas until the product has dried. Two weeks after application scarify vigorously to remove dead moss. Do not apply during drought or freezing conditions. For persistent or heavy moss infestations a further application may be required at 40 day intervals, not to exceed maximum number of applications (3 per year).

## RESTRICTIONS OR WARNINGS

Do not spray onto surfaces other than grass to avoid staining.

## SPRAYER DETAILS AND APPLICATION RATES

- Suitable for use in all types of sprayer calibrated to apply sprays at a volume of 650 litres per hectare.
- Use low pressure fan jets to give a high volume coarse spray to penetrate the dense moss.
